#### 2021 TAX BILL SALE

Elwood Caudill Jr, Rowan County Clerk and the Rowan Fiscal Court pursuant to KRS 424.330, announce that the 2021 Delinquent Real Property Tax Bills are being offered for sale. The list of Certificate of Delinquency is available for public inspection during the hours of 8:30 AM - 3:30 PM, at the County Clerk's Office located at 600 W Main Street, Morehead KY. The list may also be inspected on the <a href="http://kydtax.smllc.us">http://kydtax.smllc.us</a> website, with a link to the delinquent tax list and also, <a href="http://rowan.countyclerk.us">http://rowan.countyclerk.us</a>. The tax sale will be held at the Rowan County Courthouse, on August 24th, 2022, beginning at 10:00 am, in the Fiscal Court Room. All interested participants must register with the County Clerk's office by the close of business on August 12th, 2022. The sale will be conducted in a manner similar to a professional sports draft in accordance with the provisions House Bill 262 enacted by the 2009 General Assembly. The following methods of payment will be accepted by the Clerk's Office for third party purchases: Cash or Checks. If paying with a company check, we will need a letter from your bank.

A registration fee of \$10.00 per bill, up to 25 bills, or a maximum fee of \$250.00 for purchases over 25 bills, will be required of all registered purchasers. Said fee will need to be paid with registration. If you have any questions, please contact the County Clerk's Office at (606) 784-5212.
