During the time period between the submission of the list and the tax sale date (August 30<sup>th</sup> 2023 10:00 am), the clerk shall review the lists to identify which 3rd Party Purchaser holds the most recent prior year tax claim.

Failure of a 3rd Party purchaser to properly and timely submit a purchase list of PRIOR year claims shall result in the loss of their purchase preference. The applicable certificate of delinquency will then be placed in the pool of certificates to be sold at the tax sale.

Please attach a separate list of each CURRENT Certificate of Delinquency you intend to purchase at the sale. For each certificate, please provide the follow information :

- Tax Bill Number
- Taxpayer Name
- Amount due on the certificate of delinquency

No deposit required on current certificates, total due at time of sale.

Acceptable forms of payment include: Cash, Certified Check, Cashier's Check or a Business Check with letter of credit from your bank. Payment due at end of sale.

Registration fee: Total number of certificates listed in Item 4 multiplied by \$10.00.

The maximum registration fee \$250.00.

Lien Filing Fee: \$45.00 for each bill purchased. Please include a separate check for filing liens.

#### 2022 TAX BILL SALE

Elwood Caudill Jr, Rowan County Clerk and the Rowan Fiscal Court pursuant to KRS 424.330, announce that the 2022 Delinquent Real Property Tax Bills are being offered for sale. The list of Certificate of Delinquency is available for public inspection during the hours of 8:30 AM - 3:30 PM, at the County Clerk's Office located at 600 W Main Street, Morehead KY. The list may also be inspected on the <a href="http://kydtax.smllc.us">http://kydtax.smllc.us</a> website, with a link to the delinquent tax list and also, <a href="rowan.countyclerk.us">rowan.countyclerk.us</a>. The tax sale will be held at the Rowan County Courthouse, on August 30th, 2023, beginning at 10:00 am, in the Fiscal Court Room. All interested participants must register with the County Clerk's office by the close of business on August 18th, 2023. The sale will be conducted in a manner similar to a professional sports draft in accordance with the provisions House Bill 262 enacted by the 2009 General Assembly. The following methods of payment will be accepted by the Clerk's Office for third party purchases: Cash or Checks. If paying with a company check, we will need a letter from your bank.

A registration fee of \$10.00 per bill, up to 25 bills, or a maximum fee of \$250.00 for purchases over 25 bills, will be required of all registered purchasers. Said fee will need to be paid with registration. If you have any questions, please contact the County Clerk's Office at (606) 784-5212
